TERMS AND CONDITIONS TOWARDS FIXATION OF FOREIGN EXCHANGE RATE

Cash distribution of SAR1500/- per head to 15000 pilgrims' approx (Purchase is optional and depend on the Hajis)

- 1. The number of Pilgrims expected to proceed for Haj 1443 (H) 2024 through West Bengal State Haj Committee is around 15,000. Every Pilgrim(s) minimum requirement will be 1500 SAR in cash to meet the day to day expenses during Haj journey in the Kingdom of Saudi Arabia. The Saudi Arabian Riyals in cash will be given to the Pilgrims at the Embarkation Point, before their departure to Jeddah/ Madinah (KSA), by Haj Charter Flights. The Haj Flights are expected to commence from 06th May, 2024 or thereafter and continue for around 20 days.
- 2. The Pilgrims shall travel from Kolkata Embarkation Point; the SAR exchange counter to be installed at the following centers:-
- A. Madinat-ul-Hujjaj, New Town, Kolkata.
- B. Haj House, Park Circus, Kolkata.
- 3. WBSHC will select the first three agencies offering highest rates provided all agree to offer H1 rates. If any of the first three agencies fails to agree to the above terms the offer will automatically move to the 4th agency and so on till three agencies are finalised.
- 4. The bank shall hold the Saudi Riyals in cash in its custody on behalf of the West Bengal State Haj Committee and make requisite arrangements for its transportation from Saudi Arabia to India and up to various centers of Embarkation Point mentioned above. The bank/ agency shall be required to make appropriate arrangements at the centers of embarkation point for distribution of Saudi Arabian Riyals in cash to the Pilgrims Necessary insurance cover shall also be required to be obtained by the Bank.
- 5. The West Bengal State Haj Committee will provide general assistance for allocation of a suitable space at the Embarkation points for disbursement of Saudi Riyals in cash to the Pilgrims.
- 6. The bank/ agency shall provide certified copy of the disbursement statement of accounts daily to the West Bengal State Haj Committee at each facilitation point without any charges.
- 7. The dress, behavior and appearance of the bank officials dealing with the pilgrims should be commensurate with the spirit of the occasion.
- 8. The banks interested in handling this assignment may quote the fixed exchange rate in sealed cover for issue of Saudi Arabian Riyals in cash in respect of the Pilgrims of Haj 15000 (approx) pilgrims, in the office of the West Bengal State Haj Committee, Kolkata. The rate shall be fixed and valid for the entire Haj Season.
- 9. Like all previous years there may be stall from government agencies like State Bank of India etc.

Note:-The finalization of the tender process shall be subject to any instruction issued by Election Commission of India (ECI).

Earnest Money:

As earnest money of Rs. 1 Lakh shall be required to be deposited by every tenderer in favour of machine generated Relevant Account no. in the form of RTGS/NEFT of any Bank as per Govt. Order` (other than there exempted as per rule).

Refund of EMD:

The earnest money of all the unsuccessful tenders will be refunded as per online system as per Govt. Order No. 3975-F(Y) dated 28th July 2016 from Secretary, Finance Department Govt. of West Bengal.

If after issue of work order, Bank/Agency fail to take up the job or left the job halfway/ incomplete, the entre EMD will be forfeited and the firm will be Blacklisted.

Other terms and condition:

- 1) No Conditional /incomplete tender will be accepted under any circumstances.
- 2) List of technical qualified bidders will be published in the web portal only.
- 3) During scrutiny, if it comes to the notice of the tender inviting authority that the credentials or any other documents are incorrect/manufactured /fabricated or incomplete in any respect then the tenderer will be out rightly rejected without any prejudice.
- 4) Before issuance of work order the tender inviting authority may verify the original credential and other documents of the lowest tenderer if found necessary.
